In light of the above facts, we hereby restrain any persons including M/s Trak Chemicals Pvt. Ltd. from carrying on any construction activity in the area around Kapurthala Estate or the Savoy Hotel which have been declared as forest area under the provision of the Indian Forest Act.

Let Notice be also issued to M/s Trak Chemicals Pvt.

Ltd. who are directed to be impleaded as Respondent No. 5 in the main Application.

Amended Memo of Parties be filed by the Applicant before the next date of hearing.

Liberty to move Application for vacation of the order is granted.
