2 M 1	It is brought to our notice that the individuals,
	whose illegally erected shops/dhabas in the forest area
	were directed to be demolished and removed from the
	forest, had approached the Hon'ble Apex Court and some
	of them have been granted interim order of status quo.
	It is further pointed out that some of the shops
	have already been demolished and persons dispossessed
	from the forest area.
	As the matter is subjudice before the Hon'ble
	Supreme Court of India, we would not like to deal with
	this aspect of the case to this extent at this stage. Let the
	matter await the Order of the Hon'ble Supreme Court.
	Admittedly, Rohtang Pass besides its geographical
	status, is a tourist attraction, but, at the same time, its
	environment and ecology needs to be protected at all
	costs. It is not disputed that vehicular traffic, littering
	and excessive human presence in that area does cause

damage to the environment. It has long term impact and affects downstream environment as well.

Consequently, we consider it appropriate to constitute an Expert Committee which should visit the entire valley of Rohtang Pass commencing from Manali. The expert Committee shall consist of the Secretary (Forests), the Director (Tourism), State of Himachal Pradesh, Chief Conservator of Forests, Divisional Commissioner, Mandi and an Expert in Ecology, which shall report to this Tribunal *inter alia* but primarily on the following issues:-

- 1. What is the extent of littering of plastic waste material in any form and other waste in Rohtang Pass commencing from the Kothi onwards?
- 2. What modes and methods have been adopted to dispose of litter, particularly to ensure its proper collection and disposal from that area in accordance with Municipal Solid Waste (Management) and Handling?
- 3. What measures need to be taken to control environmental pollution of that area resulting from vehicular traffic?
- 4. Complete proposal in regard to eco-tourism should be placed before the Tribunal particularly in light of the order passed by the State Government itself which are subject matter of CWP No. 5087 of 2013 in CWP No. 5088 of 2011, which are even listed today.
- 5. Most importantly this Committee will examine the revenue records right from the year 1969-1970 onwards and find out as to what was the status of forest in the area from Vashisht to Rohtang Pass and comparatively what is the status as of today. It will also report as to what are the steps the State Government has taken for reforestation of the area during this long period.
- 6. If the entire area from Vashisht to Rohtang pass is notified to be a forest area and if so, what non-forest activities have been permitted in that area and in that event, to what effect.

If reforestation has not been done in this area, we

expect this Committee to recommend the area upon which reforestation can be done and the period of reforestation and the expenditure needed therefor.

It is pointed out that the High Court of Himachal Pradesh appointed NEERI to submit a report which had been submitted on 12th October, 2012.

Let the State Government and all its concerned Departments submit to this Expert Committee appointed by the Tribunal a report as to what steps it has taken to comply with the directions of the High Court as well as the report submitted by NEERI. Let the Committee carry out an inspection and prepare its report as expeditiously as possible, in any case, not later than four weeks from today.

Let copy of this order be sent to the Chief Secretary of the State of Himachal Pradesh who would ensure that the directions issued by the Tribunal are carried out without demur and delay.

The State Government shall also place before that Committee such other notifications which they have issued in furtherance to directions issued by the Hon'ble High Court regardless of whether it formed part of the NEERI's Report or not.

List all these matters for hearing on 16th September, 2013.
