<b>Item No. 03 August 17, 2015</b>	<p>No Reply has been filed on behalf of the Respondent No. 6. Even the Officers from the Nagar Nigam Ghaziabad are not present. We disapprove this approach of this Authority.</p> <p>Learned counsel appearing for the Nagar Nigam Ghaziabad submits that the area in question falls in the jurisdiction of Irrigation Department and they are responsible for the same. However, Nagar Nigam Ghaziabad is dumping waste at the identified site. Though, in the Reply filed by Respondent Nos. 2 and 3 it is averred that the area in question falls in the jurisdiction of Nagar Nigam Ghaziabad.</p> <p>We direct District Magistrate, Ghaziabad, Commissioner of Nagar Nigam Ghaziabad and the Vice Chairman of Ghaziabad Development Authority should be present before the Tribunal on the next date of hearing. This direction is necessitated for the fact that whosoever is responsible, all the Departments of the Government are</p>

expected to act in coordination with each other and ensure that there is no environmental degradation and pollution caused by such activities as is evident even from the photographs filed of the massive dumping of MSW on the river bank and the same is even being burnt openly.
