- 4. The demolitions of unauthorized and illegal properties, if any, taken by the State and various Departments.

The State, Pollution Control Board and Corporation all three would inform, all the hotels on the beach of Jagannath Puri to be present before the Tribunal on the next date.

They shall show cause as to under what Authority of law such Hotels were built and under which sanctioned plan and whether they have raised any illegal construction even if they were permitted to construct in CRZ zone. All such parties would be directed to be present before the Tribunal on 08^{th} December, 2014. Notice to be issued by the State Government.
