appearing for the Applicant in Original Application No. 144 of 2015 submitted that the submission made on behalf of the Forest Department on 16th May, 2016 was that 70% of the work has been completed and balance to be completed is 30% but wrongly it was recorded that 70% of the work is to be completed and 30% of the work is completed. The Learned Counsel appearing for the Forest Department also agreed with the submission.

The Order dated 16th May, 2016 directed completion of the demarcation in respect of the Rangpuri area mentioned in Original Application No. 144 of 2016 within two weeks and also demarcation of Village Asola has to be completed by the next date of posting and the progress of the work with regard to the other areas shall also be reported by the next date. Though Tehsildar of Asola is present and seeks further time stating that four weeks time is needed to complete the work, we are not satisfied with the submission made.

A proper progress Report be submitted within two weeks stating the details of the work of demarcation already completed, the balance work which are to be completed and the exact time schedule necessary for completing the work.
