Inspite of order dated September 19th, 2014, there appears no action as regards arrangement for shifting of bio-degradable MSW, generated on account of 'Pooja Vidhis' to Nashik Municipal Corporation's MSW plant, which was agreed upon.

Learned Counsel appearing for Municipal Council, Trimbakeshwar, states that such arrangement is likely to be made within a short period.

It is very unhappy affair that inspite of long period spent, the compliances are not being made and yet bio-degradable waste is not being sent to the STP at the site of Nashik Municipal Corporation, at the cost of Purohit Sangh, as directed earlier.

Municipal Council, Trimbakeshwar, shall now immediately take steps to send within a week, to ensure that compliances are made and within two (2) weeks the bio-degradable waste is being transported to the STP of Nashik Municipal Corporation, which is being generated on account of 'Pooja Vidhis' 'Nagbali' 'Pind-Dan' 'Kalasarpa Vidhi' etc. as mentioned earlier. We make it clear that in case of failure to take such stern action, we may direct the Collector to take an appropriate action against the Municipal Council, Trimbakeshwar for failure to perform duties required under the Law, or may take penal action under Section 26 of the NGT Act, 2010, against the Chief Officer of the Municipal Council, Tirmbakeshwar, as well as penal action against the concerned
