Item Nos. 75 to 77 October 19, 2015 ss	Issue Notice to M/s. L&T by Registered post/Acknowledgment due. Notice returnable on 30 th October, 2015. The Applicant has filed an Application and has made specific averments that there are fresh encroachment and construction in the flood plain of river Yamuna, despite the specific order of the Tribunal. According to him, it has also been noticed during the inspection conducted under the directions of the Principal Committee appointed by the Tribunal. Let the Learned Counsel appearing for the DDA and NCT, Delhi and MoEF ensure that the inspection report by the inspecting team under the directions of the Principal Committee is also

placed before the Tribunal on that date.

The I.I.T., Delhi is directed to complete the project awarded by the DDA and submit a compliance report to the Tribunal before the next date of hearing.

The Principal Committee shall be present at 3:00 P.M. on 30th October, 2015 at NGT, Delhi. On that day the case will also be taken up for hearing in the court. The Committee will inspect the STP plant at Keshopur (Pilot Project) and report on its functioning to the Tribunal on that date.
