It is further brought to our notice that these unauthorized and illegal activities are causing serious pollution as broken pots and unutilized pots are being converted into C&amp;D waste which is being dumped either on the river bed or on the river itself. It is also brought to the notice of the Tribunal that these Nurseries which are getting plants in plastic bags are not collecting them and taking to proper sites and are even burning plastic on the river bank. This all is indicative of serious pollution of Air and Water and they are also extracting groundwater illegally and indiscriminately without permission from CGWA. These</p> |
