	Item Nos. 23 & 24 July 14, 2015	We direct that hearing of the cases would continue on the various issues and the applications pending before

the Tribunal will be taken for hearing on day-to-day basis.

The matter will be listed on Monday i.e. 20th July, 2015 at end of the Board.

In the meanwhile, we direct all the Corporations, Forests Department, NOIDA Authority, NCT Delhi, Ghaziabad Development Authority, State of Uttar Pradesh and State of Haryana to file a complete status report in relation to implementation of the directions issued by the Tribunal for checking the pollution caused by dust and burning of different materials. This report shall be filed, duly signed and verified by the Head of the concerned Corporation, Forests Department, DDA, Government Authorities and the State Governments. It should be pointed out that if any case of violation by any multi-storied construction project in the entire NCT, Delhi has been noticed, what action has been taken against such projects. Similarly the action taken upon violation of prohibition on burning of plastic and other materials should be placed before the Tribunal. Let this report be positively filed by the next date of hearing.

We would take up all these 21 Applications which are stated to be pending before the Tribunal for adjudication.

In the meanwhile, Liberty to all the parties to file documents, if any.
