## Appeal No. 63 of 2012

It is stated on behalf of the Haryana Pollution Control Board that Sharma Nursing Home which was violating the Waste Management Rules has been closed and is no more functional. The Pollution Control Board shall ensure that Sharma Nursing Home, Mahavir Colony, Sonepat is not permitted to function without specific Orders of the Tribunal.

Notice was issued to 11 other Hospitals/Nursing Homes which as per the Report were found to be non-compliant and violators of the relevant rules.

The service of all these 11 Nursing Homes/ Hospitals as indicated in the Order dated 15<sup>th</sup> December, 2013 is complete. Let the Reply be filed by all these 11 Nursing Homes/Hospitals within two weeks from today.

We make it clear that in the event of default of filing the Reply, we will be compelled to close these Hospital/ Nursing Homes for the above stated violations.

As far as the units dealing with collection and disposal of Bio-Medical Wastes (BMW), it is stated that all the companies/ units to which the Notices were issued have been served.

All of them pray for time to apply for seeking Environmental Clearance from the competent Authority.

The Learned Counsel appearing for the MoEF submits that they would deal with the Applications for grant of Environmental Clearance expeditiously.

We direct all these units to apply for seeking Environmental Clearance if they have not already applied. The needful should be done within three weeks from today.
