	<b>Item No. 23  December 21, 2017</b>	<b><u>M.A. No. 1502 of 2017</u></b>  The applicants are seeking directions for staying the ongoing activity of concretization in river Yamuna. The applicant contends that the respondents are doing construction of 4 to 5 feet of concrete wall in the middle of the river taking disadvantage of the permission to carry out the sheet pile work vide order dated 31 <sup>st</sup> May, 2017 and this work will damage the aquatic life of the river. Reply dated 20 <sup>th</sup> December, 2017 is filed today by the State of Uttar Pradesh wherein it is contended that the concretization work for strengthening the base of sheet piling as permitted by order dated 31 <sup>st</sup> May, 2017, is being carried out at the left side of the river as shown in the photograph at annexure-1 to the reply and no work is being carried out in the middle of the river. The photographs produced by the State of Uttar Pradesh reveal that the ongoing construction is being carried out with the excavation at the bank of the river Yamuna and not in the
