	<b>Item No. 03 July 18, 2016 A</b>	<p>Learned counsel appearing for the parties commonly conceded that this Application is covered by the judgment of the Tribunal in the case of S.P. Muthuraman Vs. Union of India in Original Application No. 37 of 2015 decided on 07<sup>th</sup> July, 2015. He further stated that on identical order was passed on 12<sup>th</sup> July, 2016 in Original Application No. 288 of 2016. Similar order be passed in this case.</p> <p>Therefore, we dispose of this application in terms of the order dated 12<sup>th</sup> July, 2016 passed in Original Application No. 288 of 2016. The Applicant shall pay 5% of the project cost. It is stated that project cost is Rs. 42.5 crores and 5% of which is Rs.2,12,55,000/- which amount they have already deposited vide receipt dated 21<sup>st</sup> June, 2016 with the Tamil Nadu Pollution Control Board. Furthermore, the Expert Committee shall submit its report to the Tribunal. The Report will be comprehensive in all respects. The order dated 12<sup>th</sup> July, 2016 shall <i>mutatis mutandi</i> apply to this case. The report as and when submitted shall be placed before the Tribunal for appropriate directions. The Applicant will not carry on any construction thereof till further order of the Tribunal.</p>
