	he would be in a position to apprise the Tribunal about the decision of the
	committee within a week.
	Shri Ajay Gupta, Learned Counsel submits that in the meanwhile
	the District Collector may be directed to forward the blue print of the
	school building as was constructed at Villlage Naka Pata so that the
	Association may take up estimation of the cost and they may be permitted
	if allowed to raise the construction at the site at Natho Ki Basti without
	waste of time as per the blue print and design approved by the District

Collector under the 'Sarva Shiksha Abhiyan' under the supervision of an Officer to be appointed by the District Collector. Shri Sachin K. Verma, Learned Counsel is directed to convey to the District Collector the aforesaid proposal and consider the same for seeking the views and obtaining the approval of the District Collector on the aforesaid proposal by the next date of hearing.

The SHO, Police Station, Vishwavidyalaya, Gwalior is present. Shri Sachin K. Verma, Learned Counsel appearing for the State has submitted that in view of the ensuing Lok Sabha elections a drive is being carried out for obtaining information of persons against whom several cases are already registered and it was only by way of routine exercise the Applicant was summoned at Police Station, Vishwavidyalaya. It is further been stated that the Crushers are not located within the jurisdiction of Police Station, Vishwavidyalaya and are concentrated in the jurisdiction of Police Station Bilowa and as such the SHO, Police Station, Vishwavidyalaya is not connected to the present matter.

We have noted the aforesaid explanation. We emphasise that the District Administration should be sensitive towards the safety of those citizens who self-lessely bring matters to the notice of the Courts / Tribunals on issues relating to environment and public interest. Once the matter has been brought to our notice it shall be dealt with in accordance with law and followed to its logical conclusion notwithstanding the fact that in such matters the Applicant wishes to peruse the matter personally or not.
