Perused.</p> <p>Controversy has been raised over the supply of water through the piped water connections to the various projects of Respondent Nos. 7 to 18. According to the Applicant, the fact of getting water through water connecting pipelines is still haunted with controversy. He, therefore, is seeking direction to the Respondent No. 4 – HUDA to physically inspect and submit detailed videography report of all the project sites of the Respondent Nos. 7 to 18 referred to in the main application.</p> <p>We hope that this investigation will bring a end to the controversy raised, particularly in light of the revelations made by the HUDA as per chart reproduced herein below:</p>

Let Respondent no. 4 – HUDA physically inspect the project sites of the Respondent nos. 7 to 18 as referred to in the original application and make record of the inspection through detailed videography and shall answer the following queries:

1. Whether the projects have received water through regular water pipelines/connections?
2. If no such water line connections have been provided, what is the source of the water supply to the concerned

project?

Advance notice of the visit for the purpose of physical inspection shall be given to the respective units. Concerned Respondents shall forthwith furnish to the learned Counsel appearing for the HUDA their e-mail address for the purpose of facilitating service of advance notices. Liberty granted to the applicant to attend the inspection proceedings. Advance notice shall also be dispatched to the applicant by e-mail on the e-mail addresses furnished by him.

Learned Counsel appearing for the Applicant submits that he will take instructions for deleting the parties who are found to be having authorized water connections.
