	<p>Item No. 03-07</p> <p>February 02, 2015 A</p>	<p><u>M.A. No. 68 of 2015</u></p> <p>The Affidavit is permitted to be taken on record.</p> <p>With the above direction, M.A. No. 68 of 2015 stands disposed of.</p> <p><u>MAIN MATTERS</u></p> <p>We are not satisfied with the Affidavit filed on behalf of the Board. Let a proper Affidavit now be positively filed within one week from today and the copy of the relevant records shall be annexed to the Affidavit. In the Affidavit it will be stated as to how many STPs have been established under the scheme, what is the state of affairs of the existing sewage pipeline and what steps are proposed to be taken. The report of the consultant to whom more than Rs. 18 crores has been paid shall be filed before the Tribunal. It will also state as to what project has been carried out by spending Rs. 1.200 crores under this scheme. The Corporation is also directed to verify all the facts and also file its Affidavit within one week from today. List this matter on 11th February, 2015 in this regard.</p> <p>We direct the Medical Superintendent of PGI Chandigarh to submit a report as to the impact of pesticides as well as the contamination of underground water on health. Punjab Pollution Control Board shall assist the Medical Superintendent in this regard. The samples should be collected and analysis report should be submitted before the Tribunal.
