Item No. 08 March 23, 2017 The substance of the grounds urged in these applications is that they are established companies running their plants which have now been ordered to be shut down by the order of the Respondent No. 1. They, therefore, seek to participate in these proceedings as an intervener.

The Learned counsel appearing for the Applicant submits that if at all they are permitted to participate in the proceedings as intervener and if they file their pleading, the Applicant be given a right to traverse and file reply thereto. The Learned counsel appearing for the Board also has no objection to allow these applications. In the circumstances, we are of the opinion that if not necessary but they are proper parties to this proceeding for the reasons if any order is required to be passed with regard to alleged pollution being caused by them to implement such orders, their presence would be necessary.

Subject to just exception, we allow these applications detailed in the para supra. The applicants are permitted to participate in the proceedings as interveners only. They may obtain copy of the proceedings if they so desire from the website. The amended cause title be filed by the Applicant within two weeks from now after serving copy on the Respondents. The Applicants impleaded today may file their statement, if any, within two weeks from now after serving copy on the Applicant's Counsel.

Thus, M.A. Nos. 333/2017 to M.A. No. 342/2017, M.A. Nos. 345/2017 to M.A. No. 349/2017 stand disposed of accordingly.
