	<p>Item No. 01</p> <p>March 19, 2015</p>	<p><u>M. A. No. 240 of 2015</u></p> <p>Notice.</p> <p>The Learned Counsel appearing for the Board and DPCC accepts the notice. Having heard the Learned Counsel appearing for the parties, we allow M. A. No. 240 of 2015 without prejudice to the right and contention of the parties and appellant is permitted to be impleaded as Respondent in the main Appeal No. 1 of 2015.</p> <p>Accordingly, M. A. No. 240 of 2015 stands disposed of.</p> <p><u>M. A. No. 241 of 2015</u></p> <p>Notice. The Learned Counsel appearing for the Respondents pray for time to submit Reply. Let Replies be filed within four days from today with advance copy to the Learned Counsel appearing for the Appellant.</p> <p>The Learned Counsel appearing for the Appellant submits that all the five hotels stated in paragraph -1 of the Application would shut their operation forthwith and would comply with the requirements of law. They would become compliant and non-polluting units.</p>

Let all these hotels stop their operation forthwith.

The team of DPCC and the CPCB shall inspect these hotels on Sunday i.e. 22nd March, 2015 and would submit a report to the Tribunal immediately. Thereafter the matter be listed for hearing on 24th March, 2015.

We make it clear that all these hotels should be operational on 22nd March, 2015 on the basis that there is 100 per cent occupancy.

The effluent shall be analysed and source of water will be pointed out whether these hotels are paying cess or not will be noticed and all this will be brought on record by the inspecting team.

We further direct that all the hotels to which time was granted by the DPCC to install anti polluting devises or ETPs/STPs would be inspected in the coming four days and if they have not started any work for installation of equipments and for taking anti-polluting devices, in such cases these hotels shall also be ordered to shut down, would be sealed and their electricity and water connection shall be disconnected forthwith and restored only on Saturday afternoon i.e. 21st March, 2015. The SHO and the Officer of the DPCC and the concerned SDM shall be responsible for compliance of this order.

List the matter on 24th March, 2015.
