	Mr. Sabir Khan is carrying on illegal and unauthorized
	mining in that area. He carries this illegal mining from
	M.P. and sells in Uttar Pradesh. He is stated to be a
	Mining Lease Holder in UP and is carrying on the illegal
	and unauthorized mining in M.P. They have proposed to

impose a penalty of Rs. 4,50,00,000/-upon the said person. Since this person named Mr. Sabir Khan, S/o Mr. Alim Khan has reportedly carried out the illegal and unauthorized mining, we direct issuance of Notice to this person to show cause why we should not direct his prosecution in accordance with law and direct him to pay compensation for restoration and restitution of ecology and environment of the illegally mined area. Learned counsel appearing for him accepts Notice. Let Reply be filed within two weeks from today. Reply shall also be filed to the report of the District Magistrate as afore indicated.

Notice shall also be issued to Mr. Rajbahadur Yadav, S/o Mr. Tiria Yadav, R/o Village Chhanhiapurva (Pritampur), Tehsil Naraini, District Banda, U.P. to show cause, as he is also stated to be carrying on illegal mining in District Banda, U.P.

Show cause notice shall also be issued Mr. Nasif Khan who is reported to be carrying on illegal mining in Chhatarpur District.

Let the District Magistrates of District Banda and District Chattarpur ensure that these persons do not carry on illegal and unauthorized mining. Reply should be filed as afore-indicated within two weeks from today with advance copies to all the Learned counsel appearing in the case.

List this matter for recording of evidence on which date the District Magistrate of both the Districts would be present in person along with other Officers.
