Perused.</p> <p>Grievance regarding the breach of Environmental Clearance conditions requiring manual sand mining is raised in the present application.</p> <p>We have directed the joint team of Respondent No. 3 – Department of Geology & Mines, Respondent No. 4 – UP State Pollution Control Board and the Respondent No. 7 – District Mining Officer to carry out survey of the area referred to in the application and file status report as regards the violation of the EC. Learned Counsel appearing for the Respondent Nos. 1,2,3,5,6,7 submit that the status report would be filed in course of the day, According to the status report, she submits that there is no sand mining going on in the area in question in breach of the EC conditions. Let a copy of this report to be furnished to the Applicant who may file response to it on or before the next date.</p> <p>Replies to the application be filed within two weeks with advance copies of the replies to be furnished</p>

to the applicant who may file rejoinder thereto, if any, within a week thereafter. It may be noted that no further time for filing replies will be granted and in the event of failure to file replies, the application shall proceed as if the contending respondents have nothing to say about factual contents of the application.
