By way of last opportunity four weeks time from today is granted to all the State Governments to file their respective Affidavits.</p> <p>We make it clear that we will not grant any further time for this purpose and in the event of default we would be compelled to impose costs on the Secretaries of the respective States.</p> <p>We make it absolutely clear that all six queries raised in our Order dated 19th March, 2014 should be answered specifically with required data.</p> <p>The status report in regard to sand mining on the river bank of Yamuna in the territory of Uttar Pradesh and Delhi would be filed before the next date of hearing..</p> <p>Learned counsel appearing for the State of Uttar Pradesh shall also give present status in terms of our Order dated 19th February, 2014 before the next date of hearing.</p> <p>All the Noticees who have not filed their Replies may file the same within three weeks from today.</p> <p>List this matter on 08th July, 2014.</p>
