	27007 of 2008 which states that eviction process has been
	started even on 28.03.2008. In fact the High Court has made
	an observation that there has been encroachments by the
	fishermen in beach area in S.No. 12 classified as Village Site
	(Grama Natham) and that was extracted from the counter
	affidavit filed by the Tahsildar, Shozhinganallur. Ultimately the
	Hon'ble High Court has directed in the light of the report of
	the Tahsildar with a direction to adhere to the assurance
	given in the additional counter affidavit wherein the Tahsildar
	has assured that the encroachers will be removed and the

Writ Petition came to be disposed of with a direction to take appropriate action.

Now, that the fishermen have stated that they have been living in the said area for a long time and it is also said that the Government has put up the construction for them and the people are living there.

We direct the Tahsildar to give the names of encroachers referred in the counter affidavit filed by the Tahsildar before the Hon'ble High Court as elicited in the order of the Division Bench dated 10.10.2014. In the mean time, the persons who are affected by such notices stated to have been issued by the Revenue Inspector, are entitled to file impleadment application with all necessary records.

Considering the plight of these people, we direct the Revenue Inspector who has issued eviction notices against these people, not to precipitate further until further orders are passed by the Tribunal.

The applicant, who has filed the application has made a request for police protection since large number of people who, according to him, are encroachers, are threatening him of the dire consequences. We direct the Government, particularly, the 3rd respondent, the Commissioner of Police, Greater Chennai, to provide adequate protection to the applicant I.H.Sekar.
