Date and Remarks Item No.4 6<sup>th</sup> January, 2017 Order No.6

Orders of the Tribunal

GCZMA files affidavit dated 4<sup>th</sup> January, 2017 along with copies of the Reports – (i) Undated Report on Carrying Capacity of Beaches of Goa prepared by NCSCM edited by Professor Ramchandar (page 1 to 133), (ii) Undated Report on Coastal Sand Dunes of Goa prepared by NCSCM identifying the Sand Dunes (page 1 to 30 with 8 map-sheets attached). Let the copies of this affidavit and Reports be furnished to the Applicant. Applicant admits the receipt of the copies.

Order dated 17<sup>th</sup> December, 2014 requires the MoEF to conduct inspection and report compliance of the directions.

According to the Applicant, several directions were passed from 9<sup>th</sup> February, 2016 till 7<sup>th</sup> October, 2016 for demolition of the shacks/cottages which came up in violation of the Order dated 17<sup>th</sup> December, 2014. Affidavit dated 26<sup>th</sup> December, 2016 of the Member Secretary, GCZMA at Volume – IA gives revised table pertaining to demolition drive and its status taluka-vise. It is revealed that

Item No.4<br/>6th January,<br/>2017demolition drive is complete in Taluka – Salcete and Canacona.<br/>According to this table, only 28 shacks, out of this 27 structures are<br/>subject matter of the list pending before the Hon'ble High Court of<br/>Bombay at Goa are left untouched. Learned Advocate General Mr.<br/>Lotlikar on instructions make a statement that demolition drive as<br/>regards Taluka – Salcete was completed on 17th December, 2016<br/>and as regards Canacona was completed on 15th December, 2016.

The Applicant refutes this contention. According to him, the shacks have not been demolished and the Member Secretary GCZMA is misleading the Tribunal by filing false affidavits. He refers to the photographs at page-106 to 118 annexed to the affidavit dated 29<sup>th</sup> October, 2016 as the proof of violations and the perjury committed by the Member Secretary, GCZMA. He submits that so far as violations are concerned, he invokes the provisions of Section 25, 26 and 28 of the National Green Tribunal Act, 2010.

We have already observed vide Order dated 7<sup>th</sup> December, 2016 that this Tribunal will not be justified in entertaining the present Application to punish the Respondents for offence under Section 26 of the National Green Tribunal Act, 2010. Mainly we are concerned with the execution of the Order as contemplated under Section 25 of the NGT Act, 2010 which obliges this Tribunal to execute its Order as a decree as per the provisions of CPC.

We, therefore, direct MoEF to give its compliance report in terms of the Order dated 17<sup>th</sup> December, 2014 passed in Application No.3/2014.

Learned Counsel Mrs. Supriya Dangare standing Counsel for MoEF submits that she would communicate this Order to the MoEF and appear on their behalf provided the Applicant and other authorities have no objection for her appearance as she had appeared in the main proceeding before passing of the Order in execution for Respondent No.4 – M/s. KHR Hospitality India Limited. The Applicant as well as learned Counsel appearing before us have no objection if a brief on behalf of the MoEF is held by Mrs. Supriya Dangare in the present case.

Let MoEF file its compliance report before the next date. In the meanwhile, the authorities to take note of the allegations of the existence of the shacks made by the Applicant. We direct the State of Goa to place before us the complete record of demolition effected Item No.4 6<sup>th</sup> January, 2017 Order No.6 from time to time, particularly of the structures which are alleged to exist as per the Applicant. We direct Deputy Collector, Salcete and Deputy Collector, Canacona District South Goa or their official representatives to visit the sites indicated in the photographs referred to hereinabove on 12<sup>th</sup> January, 2017 at 11.00 A.M. and submit their Report on or before the next date. The Applicant shall report to the office of the Deputy Collector, Salcete to begin with at 11.00 A.M on 12<sup>th</sup> January, 2017 and thereafter, the joint inspection of the sites as pointed out by the Applicant with reference to the photographs will commence.

List it on 10<sup>th</sup> February, 2017.
